Overview main insitutional activities 2003 – 2017 for

SOS RULE OF LAW and the RIGHT TO KNOW

- 2003 2013: Starting from the initiative "Free Iraq Only alternative to the War" follows an in-depth in-house research on the mechanisms behind the decision-making. Accompanied by a series of bilateral meetings (in particular with Members of both Chambers of the UK Parliament, Arab League representatives, journalists, and activists). Research and encounters, in combination with a decadelong struggle for the Italian citizens' right to be properly informed in order to be able to make democratic choices, leads to the identification of the lack of a citizens' right to know within the international human rights framework.
- February 2014: First International Conference on the Rule of Law and the Right to Know at the European Parliament and the European Commission, hosted by then European Commissioner (currently President of the European Parliament) Antonio Tajani, bringing together politicians, human rights activists, and academics.
- March 2014: Meeting of a Nonviolent Radical Party delegation headed by Marco Pannella with High Commissioner for Human Rights Zeid Ra'ad Al Hussein

Hussein to discuss the right to know. The proposal is met with interest, and further development is encouraged.

- June 2014 May 2015: Presentation of the Written Proceedings (published in English, French and Italian) of the February 2014 Conference at the House of Commons in London (hosted by Norman Baker MP, former Under-Secretary for Home Affairs); French Senate (hosted by Senator André Gattolin); Palais des Nations in Geneva (seat of the UN Human Rights Council, with the active involvement of Italian Permanent Representative Maurizio Serra); Camera dei Deputati in Rome; and the Institute for Philosophical Studies in Naples.
 The most significant contributions during these additional debates are bundled and have been published in Italian.
- March 2015: Meeting of Nonviolent Radical Party delegation with Prof. Em.
 M. Chérif Bassiouni, to lay the foundations for the development of a scientific study for the definition of the right to know.
- **July 2015: Second International Conference** on the Rule of Law and the Right to Know at the Italian Senate, bringing together politicians (with the participation of Italian Minister of Foreign Affairs Paolo Gentiloni and Niger's Minister of Justice Marou Amadou), human rights activists, and academics. The Written Proceedings of this conference have been published under the title "SOS Rule of Law" in Italian (ISBN Number 978-88-95284-60-6).
- July 2015 ongoing: Launch of the Appeal for the affirmation of the right to know redacted by Prof. Em. Aldo Masullo. Thanks to local activists, the Appeal has

so far been adopted by 40 city and/or regional council across Italy. It has been signed by over 50 international personalities.

September 2015 – September 2016: Scientific investigation by Laura Harth into the background and definition in legal and public policy terms of the Right to Know at the University of Exeter, in collaboration with the Nonviolent Radical Party, funded by the ESRCSouth West Doctoral Centre and supervised by Prof. Claudio M. Radaelli. The study is accompanied by a legal definition by the Members of the Scientific Council: Prof. Francesca Graziani for the Italian Organization for the International Organization (SIOI); Prof. Natalino Ronzitti for the Istituto Affari Esteri (IAI); and Avv. Ezechia Paolo Reale for the Siracusa International Institute for Criminal Justice and Human Rights.

Upon completion, both studies are examined and developed further by the full Scientific Council, headed by Prof. Em. Chérif M. Bassiouni.

- September 2015 April 2016: Bilateral meetings with Diplomatic
 Representatives in Rome to present the campaign on the right to know and request their endorsement and participation at the round-table conference in Geneva.
 Meetings with Officials from the Italian Ministry of Foreign Affairs to endorse the active participation of Italy.
- May 2016: Round-table conference "SOS Rule of Law" at the Palais des Nations in Geneva (seat of the UN Human Rights Council) on the Rule of Law and the Right to Know, with the active participation of the Permanent Representatives to the United Nations Institutions in Geneva of Canada, Italy, Ireland, Mexico and Morocco. Over 23 delegations participate in the meeting.
- September 2016: Hearing at the Foreign Affairs Committee of the Italian Chamber of Deputies on the right to know, with the participation of former Italian Minister of Foreign Affairs Amb. Giulio Terzi di Sant'Agata and former Italian Minister of Foreign Affairs Franco Frattini. Subsequently, the Committee adopts a Resolution calling for the further involvement of the Italian Government.
- November 2016: International Conference at the Italian Senate, hosted by President of the Italian Senate Pietro Grasso. Presentation of initial findings by the Scientific Council by Prof. Em. Chérif M. Bassiouni.
- **12 May 2017: International Conference** "Information and Public Debate in 21st Century Consolidated Democracies: What Issues and What Reforms?"; at the Italian Senate with the participation of former Italian Minister of Foreign Affairs Amb.
